Corner Green Residents Society Limited Chairman's Statement

At the last AGM held on the 25 November 1992, Andrew Mintern, Claude Perera, Martin Jones, Neil MacCormick and myself were elected to serve as directors for a further year together with Simon Garmston.

The exterior painting of the garages was completed over the winter of last year at a total cost of £1,350 which has been met from the exterior painting reserve brought forward.

The road continues to be a concern. Work to the pavement and to repair the worst of the pot holes together with resurfacing of the pavement was completed in the Spring at a cost of £2,284. Further provision has again been made in these accounts towards the future cost of refurbishment of the remaining surface in 1994/95.

The collection of a small number of delinquent maintenance contribution accounts remains a difficult responsibility for the Directors, with the need to balance the regard for individual personal circumstances against the financial security of the Society. Of the £1,645 due to the Society at 31 March £544 has since been cleared and the balance is subject to ongoing review by the directors.

The directors and I continue to be aware of the need for restraint in these difficult economic times and whilst we need to balance the longer term needs of the Company's reserves to meet its obligations, for the third successive year we are proposing not to increase the level of maintenance contributions for the forthcoming year.

The Directors meetings remain open for any residents to attend. If you have issues which you feel should be addressed then either contact myself or one of the other directors.
