Action

1. Minutes of Last Directors' Meeting

The minutes were agreed as an accurate record.

2. Matters arising from Directors' Meeting

Arising from minute 2 (parking of unused vehicle) Rosie Hewson advised that the owner had not responded positively to the request to move the vehicle in question.

Arising from minute 3 b) I) (garage painting) David Howes to ask Mark Helm for address of tenant of garage next to dump.

Arising from minute 3 d) (painting contract) and at the suggestion of a company member, Directors agreed to give Richard Hewson a vote of thanks and a small token of their appreciation of his efforts in connection with the painting contract. Rosie Hewson declared an interest and took no part in the discussion of resolution.

3. Treasurer's Report

Tim Layton advised that he was awaiting a statement to check which households have not yet raised their monthly contributions. Reminder to accompany minutes.

Tim advised that he had secured a more competitive quote from London Electricity to retain the contract for supply of light and power to garages and green. Directors authorised Tim to enter into a new contract on the revised terms and thanked him for his efforts.

Directors discussed arrears of service charges on an off-green property arising from previous owners. They asked Tim to write to the current owner accepting his offer of part payment from himself, but emphasising that the remaining arrears were outstanding due to failure of buyers' solicitors to establish level of debt at transfer,

rather than any negligence on the part of the society or its directors.

Directors noted that for on-green properties arrears were a charge against the property which transferred with ownership, and it was general conveyancing practice for buyers' solicitors to confirm sellers were up to date with service charges.

Tim Layton advised that he was standing down as Treasurer but would continue as a Director. Directors thanked him for his efforts during his term as Treasurer and asked Rosie Hewson to canvass company members for interest as his successor.

Directors expressed concern about outside residents and contractors parking vehicles on the access road and its pavement, and consequent damage to the latter. They agreed to allow Simon to sort out replacement of entrance signage before addressing these issues with relevant owners.
