3. Works

Triennial Painting

a) Specifications for individual houses' prior-to-painting had now been circulated but MC was chasing Gilbert and Caswell for photographs to support the text. He was also chasing the painting specification from Gilbert and Caswell since time was getting tight for issuing tenders in time for late May painting.

Directors agreed that the next Directors' meeting on April 19th (see item 6 below) should be opened up as an Extraordinary General Meeting to consider award of the painting contract if by that time tenders for the painting had been received.

Bollards

b) The damaged bollards behind No 18 had been removed.

Damage to Pond Road

c) A letter had been drafted to Blackheath Cator Estate Residents Ltd relating to the damage to Pond Road at its junction with the Corner Green access road.

4. Gardening Committee

Replacement of Felled Robinia Adjacent No 9

- a) Further to their discussion at the January 19 meeting DH confirmed that the area adjoining number 9 where the London Plane was planted was in the company's ownership and control.
- b) Directors noted the response of Stephen Peart on behalf of the Gardening Committee to their Jan 19 suggestions. They noted the gardening committee's view that failure to replace the felled Robinia with an appropriate tree in the same location would set a dangerous precedent in terms of departure from the original planting scheme, with no strong reasons for setting that precedent.

- c) MC reported that he had received a quote of £300 + VAT for converting the area adjoining number 9 to hardstanding. He estimated that the cost of converting the dump area to hardstanding would be somewhat higher because it was larger and there was a tree stump which would have to be removed.
- d) Rosie Hewson advised that she had not yet heard from Tim Layton regarding the potential costs/savings from Seasons if the dump were removed permanently.
- e) Directors agreed that the London Plane should be moved from its current location to a site within the area adjoining number 9 as close as practicable to that of the felled Robinia it replaces.

f) Directors agreed that investigations should continue into the practicability and cost of getting rid of the dump and replacing it with an area of hardstanding for parking.
