1. Minutes of Last Directors Meeting of 27th January 2003 approved

2. Matters Arising

- a) Public Liability claim in respect of the Keep resident's fall in the road belated letter received from Insurers explaining that they met the claim on grounds that the claimant would have been successful if matter taken to court. BCER advised of our experience.
- b) Rights of Access to CGRS land by adjoining properties. No 62 being approached by TL TL for their annual payment
- c) Clearance of Garden waste from the tip cost of skip hire and clearance have doubled since last year. Residents are asked, please, please, to as far as possible use their own bins and bags for vegetation waste, rather than the tip, to reduce the cost to CGRS of clearance. Mention of this issue could usefully be put on the Residents Information sheet. (This is in need of revision DR to circulate to all DR directors for comment before next Directors meeting)
- d) Defective double glazing so far responses from Nos 4,6,7,10 and 17 to enquiry as to whether any residents wish to collaborate in double glazing replacement to lower expense. MC to check out costs. Other interested residents to contact him. One resident has queried whether substances other than wood, such as plastic, can be used when wood and windows replaced. The answer is that this can not be done at the front and only on ground floor windows at the rear, not visible from the back.
- e) 4 Pond Road. Juliet Cairns has written voicing concern about mud on the access road (now cleared by Seasons following work on the rear garden of 4 Pond Road); and more importantly about the parking of vehicles in the CGRS access road, not only because of present obstructions to visibility but also lest this is seen to set a precedent for future parking. RH is writing to Marnic stressing that future residents of 4 Pond Road may not use the CGRS access road for parking.
- f) 10 Pond Road JC has written to Mr Reza, owner of 10 Pond Road refusing his application to plant two trees in our back lane and this is no longer being pursued
- 3. EGM on 10.3.03 to discuss repairs to roads, pavement and paths, Minutes of this to be circulated. Details of suppliers of coloured tarmac (for repair to circular path round the Green) have been obtained and passed to MC. A quote from Jeff Read is awaited The Land Registry have provided papers which suggest that the roadway where repairs are needed to CGRS pavement at the rear of No 19 may be owned by Corner Keep DR to obtain a plan from the land registry and provide this and other documents to RH who will approach the chair of Corner Keep to discuss their sharing repair costs. (RH also to raise with him problematic parking by one Corner Keep

resident which causes traffic to cut the corner and thereby likely led to the damage to the pavement)

4. Finances

One owner, having failed to increase his standing order when maintenance levels were TL raised in 2002, has now stopped payment. Renders him subject to punitive interest,

5 Gardening Issues

- a) Newplanted daffodils on the Green appreciation voiced to Stephen Peart
- b) Tree surgeon's report is in residents can get a copy from TL. One large tree on the corner behind No 9, across from the tip, is in need of felling. (Stephen Peart asked to mark this with a cross so residents know which one). Cost likely to be in the region of £800 so at least two estimates to be obtained and need to call EGM to get sanction for such expenditure. Cost of this would come from General budget rather than that of gardening committee
- c) Other spending on planting is needed not least to fill the gap to the side of No 18, and to replace the tree which fell in the top car park. Gardening Committee should prepare forecast of likely costs for 12 months following the next AGM. Committee also is seeing other members.

6. Any Other Business

- a) Roof top satellite dish, visible from the Green, one has been installed, likely in DR ignorance of rules. DR to write asking for it to be relocated.
- b) AGM date set for Monday 16th June DR to book hall.
